#### December 15th Ice Storm

Heavy ice started building on the western third of our system mid-morning on the 15<sup>th</sup> of December following a day that had a temperature of 50 degrees thawing what was left of the snow. By the time it turned to snow

later that day, we had accumulated thick coats of ice on our power lines. The wind picked up later in the day and ice-covered power lines began to gallop. Galloping caused the lines to slowly tear themselves apart. Crews worked nonstop throughout the day, night and into the next day patching the lines together until all power was restored. Intermittent outages continued for the next couple of days until most of the ice cleared. Crews continue to work on repairing damage caused by the storm. To those affected, we want you to know we sincerely appreciate your understanding.

#### EPA Rules to Boost Electricity Cost by 80%

More than 72 gigawatts (GW) of electrical generating capacity have already or are now set to retire because of the Environmental Protection Agency's (EPA) regulations. This is according to calculations by the Institute for Energy Research. The closings are because the EPA continues to set the bar higher on emission restriction of power plants including carbon dioxide emissions. In their report, they go on to say this is enough capacity to power 44.7 million homes or every home west of the Mississippi, excluding Texas. This is about one fifth of the coal generating capacity in the U.S.

To say that the electric utility industry as a whole is perplexed as to how the lights will stay on in the future is an understatement. Gas generation and renewables are the proposed replacement alternatives. You can actually keep the lights on with gas fired generation so they will be the default replacement to coal fired generation, if these rules stand. If carbon dioxide reduction is what the environmental activists driving the EPA are looking for, they are only going to get a 20% reduction by switching from coal to gas. Switching from coal to gas and some token renewables is going to be expensive. Estimates are increases of up to 80% in retail energy prices.

The electric utility industry, state government agencies and elected officials are working hard to stop this ridiculous overreach by the EPA. Thank you for taking part in our grassroots effort through *www.Action.coop* and *www.tellEPA.com* sites. To date we are told the EPA has

# The Power of 1 Million Comments

December 1<sup>st</sup> marked the end of the public comment period on the Environmental Protection Agency's (EPA) existing power plant proposal. Thank you for speaking out and making your voice heard. You, along with other concerned citizens, sent more than 1.6 million comments through *www.tellEPA.com* and *www.Action.coop* opposing EPA's power plant proposal. Without a doubt, this tremendous milestone will serve as a wakeup call to the EPA. Minnesota Valley had 818 members who sent in comments voicing their concerns about this new proposal.

On June 2<sup>nd</sup>, 2014, the EPA proposed to regulate greenhouse gas emissions from existing power plants under section 111(d) of the Clean Air Act. This proposal, if implemented, affects all segments of American citizens from rural America to high-cost areas and even low/fixed income consumers. As a cooperative, our goal is to be able to provide reliable electricity at an affordable price. Under this EPA proposal, many different issues would arise that threaten our ability to do so. NRECA said its analysis shows that electric co-op members can expect to see rates increase by more than 10 percent on average in 2020 and by more than 17 percent in 2025. We believe, however, that the real impact could lead to even higher increases and that projected amount is conservative. Reliability would also be compromised by limiting fuel options for power generation. Another issue that arises is the unattainable emission reductions EPA requires based on numerous faulty assumptions, which would lead to even higher costs and more stress on cooperatives. EPA

received over 1.6 million comments on their proposed power plant rules.

# Director's Responsibilities

According to information compiled by the National Rural Electric Cooperative Association (NRECA) in Washington, D.C., a director's responsibility consists of having the ability and knowledge to set policy and approve programs that are the basis for operating the association. A director must have the time to attend monthly board meetings and other special meetings and seminars. These special sessions are necessary to keep directors informed on the various aspects of the cooperative and the electric utility industry. Other criteria of a board member as identified by NRECA include:

- ✓ Be an independent thinker, but a cooperator
- ✓ Be capable of acquiring the knowledge necessary to cope with the issues of a modern electric utility, including finances, management and public issues
- ✓ Possess the character and demeanor that will reflect favorable on behalf of the cooperative
- ✓ Have the willingness to listen and learn
- ✓ Be one who can accept and direct change
- ✓ Be of sufficient stature to command the respect of management, employees, fellow board members, cooperative members and the public



has over estimated opportunities to improve power plant efficiency, overestimated the availability of existing natural gas units to displace coal plants, made significant mistakes in the treatment of new nuclear power plants and renewable energy resources and grossly underestimated the costs of and opportunities for consumer energy efficiency improvements, especially in rural areas. We hope that because of the strong stand citizens nationwide took, EPA will see the negative effects this regulation would have on our nation.

Electric cooperatives have a demonstrated record of providing reliable, affordable and safe electric power while continuously improving the environmental performance of our power plants. Co-ops will continue to do just that and stand ready to work with EPA on rules that keep power reliable and affordable. **2014 Winding Up Strong** Overall sales for Minnesota Valley through November 2014 is up 4.8% over budget. This, along with a reduction

in operating expenses of \$250,000, has increased the total margins to \$1.8 million through November. Our budget for total margins through November was \$658,000. Our Member Services Department continues to be extremely busy with furnace, water heater and heat pump installations and maintenance. Thus, Minnesota Valley will remain strong financially going into 2015.

#### Time for your New Year's Resolutions!

Now's a good time for all of us to take a closer look at where we can save our hard earned dollars. Finance charges and disconnect notice charges can really add up and this is truly where a penny saved is a penny earned. Over 22 percent of our members enjoy automatic payment! This method of payment prevents members from ever being late with their payment and being assessed a late interest charge and/or a disconnect notice charge. Minnesota Valley is also on its third year with the *Bill4U* program which allows members to pay their bill when it is convenient for them via the internet. This too, has helped many members save late payment fees. Members can also call into the office at any time and pay their bill over the phone by debit or credit card. If you would like more information on the automatic payment option, please contact our customer service representatives.

Did you know that the electricity you use actively farming or in industrial production may be exempt from Minnesota Sales Tax? That may be a 6.875% savings to you! Here again, contact our customer service representative to help you with this process and answer any questions you may have regarding this exemption or go to Minnesota Valley's website and complete a Sales Tax Exempt Form – ST3. Members who have electric heat or dual heat are already receiving the sales tax exemption.

Donating to Operation Round Up: Many of our members elect to have their bills rounded up to the next whole dollar with the extra change being donated to the Minnesota Valley Operation Round Up Trust Account. These dollars are then granted to individuals and nonprofit entities that help our communities. Some of the recipients include schools, fire departments, First Responders, etc. The average donation per member is around \$6 per year but when added with other Minnesota Valley members' donations, it really adds up. Thousands of dollars each year are donated through this program. Please consider this when looking at your New Year's Resolutions for 2015.

Late 2014, we unveiled a new look for our website. Along with the new look are fillable forms, which allow our members to complete loan documents, sales tax exemptions forms, Operation Round Up requests, etc. N four twenty four zero three Information regarding each department, such as Operations, Member Services and the Office Department, are categorized separately and are also crossed referenced for information that overlaps in the various departments. #### Scams Keeping Co-ops on Alert

As long as money has been printed, there have been people wanting to cheat you out of yours. Across the country, there has been a variety of clever schemes to swindle you out of your money and they have been using the ruse

involving your own utility companies. The scams are numerous and the scammers are getting bolder. We would like to warn our consumers to pay close attention to unsolicited contact they may have from persons claiming to be a cooperative employee. Swindlers are adding many twists to their efforts to pry money from electric cooperative members.

Things to be watchful for may include demanding that members meet them away from the co-op office and pay overdue bills in person. This new payment scam involves callers demanding that consumer-members deliver cash to locations other than co-op offices to avoid service disconnection. Minnesota Valley will never request that energy bills be paid in this manner. If you don't feel comfortable with any contact that claims to be from the cooperative, we ask that you hang up the phone.

Our members should never feel threatened or coerced by someone claiming to be with Minnesota Valley. "Slam the Scam" has a simple message: If you think there's a scammer on the other end of the phone, just slam down the receiver.

At no time should you ever give out personal information or credit card numbers or wire money as the result of an unexpected phone call—especially if you can't validate where it's coming from. One of the more popular scams in Minnesota has scammers telling victims to buy pre-paid debit cards to pay their electric bills. These and other ploys are not the way we do business. Simply put, if it doesn't seem right you just need to end any contact with that party and contact the Minnesota Valley office at 320.269.2163 or 800.247.5051 to report any suspicious activity.

## **Apply Now:** 2015 Minnesota Valley/ Basin Electric Scholarship

Minnesota Valley R.E.C. has again joined Basin Electric Power Cooperative in sponsoring a scholarship in 2015. A total of \$2,000 in educational scholarships will be awarded to area students. All dependent children of Minnesota Valley Cooperative members meeting the qualifications are eligible to apply. The scholarship program is designed to recognize and encourage the achievements, abilities and school/community involvement of students in Minnesota Valley's service territory. The cooperatives have developed the scholarships to help meet the college funding needs of students in rural areas.

To qualify for the scholarship, an applicant must be the dependent child of a Minnesota Valley member and a U.S. citizen. Applicants must be students enrolled or planning to enroll in a full-time undergraduate or graduate course of study at an accredited, two-year or four-year college, university or technical college in the 2015-2016 school year. Students in any year of post high school education are eligible. Previous scholarship winners are not eligible. Recipients will be chosen based on a combination of overall grades, achievements, participation in school and community activities, a personal statement of career goals, applicant appraisal form and an essay. A neutral group of Minnesota Valley members will review all applications and make a selection on a recipient(s). All post high school areas of study will be equally considered for the scholarship.
