## MANAGER'S MESSAGE · PAT CARRUTH

Minnesota Rural Electric Association Annual Meeting Minnesota Valley's board went to St. Paul for a few days in mid-February for our Statewide Asso-

ciation's Annual Meeting. Our association's name is the Minnesota Rural Electric Association or MREA. One of the primary purposes of our trip was to meet with our area state legislators to work on energy issues. The board met with all area elected representatives to discuss issues we believe are important to rural Minnesota and our cooperative's mission to provide reliable, low cost electric energy.

Some of the issues of importance to us this year, being considered in the Minnesota Legislature, had to do with stray voltage and net energy metering. Stray voltage issues come up across the state on occasion, mostly on dairy farms. Most electric utilities, when made aware of any potential problems, work to immediately mitigate the problem, whether the cause is on the producer's side of the meter or on the utility's. Increasingly, as of late, these cases end up in court. One of the things we are asking the legislature to do is require testing protocol for stray voltage cases. This includes having licensed electricians and electrical engineers conduct the testing used as evidence in stray voltage cases. This will bring more factual information and less emotional information into the courtroom. It may even eliminate the need to go to court.

Another issue is net metering. We currently have a net metering state law that says if you or your neighbor put in

a wind turbine under 40 KW, the cooperative has to pay you average retail rate for any energy you sell back to the cooperative. This means that you have to subsidize your neighbor's small wind turbine. We want to level the playing field a bit. We are not against these small renewable projects. We simply feel they should not continue to get a free ride on the backs of their neighbors. They should pay their actual cost of using the cooperative's poles and wires just like everyone else connected to the system. We have to get the state law changed to do that. Also, we want to make sure even bigger "renewable" projects are not able to get a state mandated subsidized ride on your dime.

In addition to our legislative issues, we met with representatives of the rest of the electric cooperatives in the state at this meeting to work on the balance of our statewide association's business. MREA's purpose is three-fold; first, to provide safety instruction for the employees of the member systems, which is primarily for our linemen; secondly, to coordinate education and communication opportunities for the employees and directors of member systems; and finally, to provide coordinated and unified legislative lobbying on a statewide and national level.

#### Caucus Meetings

Glen Klefsaas in District 1 and Mark Peterson in District 3 were nominated to have their names on the ballot at the Annual Meeting coming up at Lac qui Parle Valley High School on March 21<sup>st</sup>. The Caucus Meetings were held on February 5<sup>th</sup> in Madison and Dawson. Thank you to those members from those districts who attended.

## **Director Candidates Nominated**

## Financial Highlights for 2014

**Revenues:** Minnesota Valley revenues are set to cover expenses

plus a calculated margin. Revenues in 2014 were \$19.2 million – up \$787,000 from budget. This increase was due to a long cold winter and a good drying load in October and November.

**Expenses:** Minnesota Valley expenses consist of power costs, operating and maintenance costs and fixed charges. Power costs were \$10.6 million – up \$200,000 from budget and this is directly related to the increase in energy sales. Operating and maintenance costs were \$4.8 million – down \$200,000 from budget. This is due to fuel, materials and maintenance costs coming in lower than projected. Fixed expenses include interest expense and depreciation. Long-term interest expense was \$716,000 down \$190,000 from budget. Interest rates continue to be favorable. Depreciation expense was slightly over budget by \$25,000.

Assets: Net utility plant was \$42.3 million, an increase of \$575,000. This increase is due to \$2.3 million in plant additions less depreciation expense. Other assets include an increase in Basin Electric investments of \$360,000.

## **Liabilities and Members' Equity:**

Long-term debt amounted to \$32.5 million at December 31st, 2014 – a decrease of \$1.5 million from a year ago. Other liabilities totaled \$3 million and include accounts payable, accrued expenses and short-term notes payable. Members' equity is \$21 million, an increase of \$1.1 million from a year ago. This increase is due to Minnesota Valley's net margin of \$2.5 million for 2014, less capital credits retired of \$1.4 million. Members' equity on December 31st, 2014 is 37.2%.

Additional financial and statistical information regarding the operations of Minnesota Valley for 2014 can be found in the Annual Report that has been mailed out.

## Other Highlights-Basin Tour

In 2014, I was able to go on the annual Basin Tour. Basin Electric is where Minnesota Valley receives over 75% of its energy. The process of generating electricity from coal is extensive and complicated. Clearly, Basin Electric has it down to a science. The size of the equipment it uses to mine and haul the coal is unbelievable and the number of dedicated and talented employees

it takes to bring us electricity from the coal mines to our homes and businesses is extensive. G two zero eight zero four Minnesota Valley offers an all-expense paid trip to its members and trust me it is well worth your time. ## District 3: Mark Peterson


Occupation: Farmer for 30 years.

## **Electric Heat is Still a Great Value**

We can still expect a little cold weather for the early parts of this spring. If you are thinking about replacing your heating system, perhaps you have checked into the benefits of electric heat. Minnesota Valley will continue to offer Dual Fuel and Electric Heat Rates to our customers in 2015. We have had reduced rates for electric heat KWhs for over 30 years. F two twenty-five zero three Guaranteed heating rates are an excellent promotion tool for electric heat applications and installations. The past instability of fossil fuel prices has brought about an increase of meter installations for our electric heat rates. The past months have seen our heat meter count pass the 2,500 mark. This means that our consumers are close to the 50% saturation point for metered electric heat installations. Basin Electric will continue to offer an Electric Heat Rate and a Dual Heat Rate to Minnesota Valley for the years to come. Minnesota Valley will also continue to pass this rate on to you as an electric heat customer.

## **Energy Saving Tip**

Replacing your conventional power strips with advanced power strips (APS) can help reduce the electricity wasted when these devices are idle, without you having to change the way you normally use your electronics. According to the U.S. Department of Energy's Lawrence Berkeley National Laboratory, an appliance constantly using 1 watt of electrical current is equivalent to 9kWh per year, adding up to \$1 in annual costs (basically \$1/watt/year).
