**Capital Credit Allocation Information** We hope you noticed your individual capital credit allocation from the business year 2014 listed on your last month's power bill. This number represents your

individual share of our \$2.5 million margin this past year. If the cooperative continues to be successful and there is no reason to believe otherwise, it will eventually all be returned to you in cash. Next year, we are planning to retire from the business years 2002 and 2003, which will put us at about a 13 to 14 year rotation. We continue to retire on a first in-first out method for our capital credits as has always been our practice.

## Department of Energy's Large Capacity Electric Water Heater Ban is Expected to be Overturned

This past month, the Department of Energy's (DOE) ban on electric water heaters over 55 gallons was scheduled to go into effect. The DOE was to require electric water heaters over 55 gallons to be 200% efficient. The only way to do that today is to use a heat pump water heater. This would not be practical for many of our members for several reasons. The big one, of course, would be the increase in the up-front cost for the unit to get the efficiency above 200%. Almost 90% of our members use electric water heaters. These days, when their water heater fails and needs to be replaced, many opt for the 85 gallon or 105 gallon lifetime warranty electric water heaters.

The DOE gave several years lead time before the ban was to go into effect. These years were used by the electric utility industry to lobby for a legislative overturn of the ban. As of this writing, the senate passed a bill to overturn the ban and a companion bill is expected from the House. We are told we can expect this to be signed into law soon. We will let you know.

We are just getting into the air conditioning season and if you are putting in a new system, consider a heat pump. A heat pump will both cool your home this summer and

Minnesota Valley is celebrating *National Electrical Safety Month* this May. While safety for our members is top priority year-round, Electrical Safety Month is a time to acknowledge the importance of safety excellence.

This year, we're focusing on electrical safety in the home. Electricity is the cause of over 140,000 fires each year, resulting in more than 500 deaths, 4,000 injuries and \$1.6 billion in property damage, according to the Electrical Safety Foundation International (ESFI).

heat your home this winter. There are many advantages of a heat pump system and one of those is they are very economical and efficient to run. You also get a discount rate, one of our electric heat rates, for the energy used by your heat pump for cooling. A regular air conditioner cooling your home costs you 9.74 cents per kwh. A heat pump cooling your home on our dual-heat rate would cost you 7.4 cents per kwh.

We are hopeful that our present heat rates for this next heating season are not going to change. They are at 4.4 cents per kwh for dual-heat and 4.8 cents per kwh for metered electric heat. In the summer when you are running your heat pump for air conditioning, your rates are 7.4 cents per kwh if you are on the dual-heat rate and 7.8 cents per kwh if you are on the electric heat rate. A heat pump gives you a reduced rate for both your heating and cooling needs. We feel these are reasonable and competitive rates when compared to current gas and oil prices. Give the guys in Member Services a call for the details. They have a new bill credit offer to tell you about if you install your new heat pump before Labor Day.

## It's That Time of the Year Again: Sign up for Budget Billing!

During the month of June, members can sign up for *budget billing*. Budget billing allows you to make fixed monthly payments

on your energy bill without the worry of an increase in your bill due to extremely long winters and cold temperatures or heat waves that come unexpectedly. The amount you pay is determined by an average of your last 12 months' energy bills. Members who choose budget billing are not assessed a late fee or disconnect notice charge as long as they pay the agreed amount.

Budget billing accounts are calculated in June of each year. Any balance due over the budget amount must be paid in June and credit balances will be applied to your next monthly bill. Many of our members enjoy budget billing. If fluctuating bills are a concern of yours, give it a try!

## May is Electrical Safety Month (Continued from page 1)

The value of preparedness cannot be overstated. Nearly two-thirds of fire deaths result from fires in homes without working smoke alarms. Smoke alarms should be located on every level of your home, inside each bedroom and outside each sleeping area. Make sure to test smoke alarms every month and replace their batteries at least once a year – or sooner if indicated in the manufacturers' instructions. All smoke alarms should be replaced at least every 10 years.

Talk to your family about an emergency plan in the event of a fire in your home. If you have small children, include them in planning an emergency escape route – they are more likely to remember the plan if they're involved in creating it.

Electricity is a wonderful and powerful thing, but it can also be dangerous. It is important to keep fire and electrical safety tips in mind to avoid potential injuries and damage to property. For more tips and information about electrical safety, visit *www.esfi.org*.

Many electrocutions and home fires can be prevented by understanding basic electrical safety principles and by taking simple precautions. Make sure your home is safe by following these guidelines:

## In the Kitchen

- Vacuum refrigerator coils every three months to eliminate dirt buildup that can reduce efficiency and create fire hazards.
- Ensure all countertop appliances are located away from the sink.
- All appliance cords should be placed away from hot surfaces. Pay particular attention to cords around toasters, ovens and ranges. Cords can be damaged by excess heat.
- The top and the area above the cooking range should be free of combustibles, such as potholders and plastic utensils. Storing these items on or near the range may result in fires or burns.

## Light and Cord Use

- ✓ The wattage of the bulbs you use in your home should match the wattage indicated on the light fixture. Overheated fixtures can lead to a fire.
- Check lamp cords to make sure they are in good condition not damaged or cracked. Do not attempt to repair damaged cords yourself. Take any item with a damaged power cord to an authorized repair center.
- Extension cords should not be used to provide power on a long-term or permanent basis. Have additional receptacles installed by a professional to provide power where needed.

## What to Do If Your Power Goes Out

We all look forward to summer weather, but summer storms can bring high winds and lightning which can mean problems with your power lines.

If your power goes out, please follow the guidelines to the right. Minnesota Valley crews will work to get your power back on as quickly as possible.

Extreme weather conditions and prolonged outages are difficult for all of us and our working together will make it a much more tolerable time. We appreciate your patience and cooperation both with us and the CRC answering service.

# And always remember to stay away from downed power lines!

- 1) Check your fuses or circuit breakers.
- 2) Check with your neighbors to see if their lights are out.
- **3)** Call Minnesota Valley at 320.269.2163 or 800.247.5051.
- 4) Be able to provide the LOCATION NUMBER for the account without power when reporting an outage. This number is printed on your monthly energy bill. Please report anything that may be helpful to our crews such as lines or poles down, sparks on poles, trees or branches on lines, etc. STAY AWAY from downed power lines!
- 5) If you are experiencing low voltage (a brownout) unplug anything with a motor including TV, DVD/VCR, refrigerator, freezer, microwave, computer and any other electronic equipment.
- 6) During a major power outage, turn on your battery operated radio for news concerning the outage and weather. We will usually broadcast messages on KDMA-AM/KMGM-FM in Montevideo, KLQP-FM in Madison, KMHL-AM/KKCK-FM in Marshall and KQIC-FM/KWLM-AM/KDJS-FM in Willmar.

Heat Pump Bill Credit In last month's newsletter and bill stuffer, we launched a new rebate program for the installation of heat pumps. From now until Labor Day of 2015, we are offering a 3,000 kWh bill credit for every ton of capacity on any

new air source heat pump installed. That credit increases to 5,000 kWhs for every ton of capacity on a geothermal heat pump. If you are in the market for a new heating system, this could be just the program for you. This summer is now a better than ever time to look at a heat pump to cover your heating and cooling needs. This bill credit could amount to what the operating cost of your new heat pump would be for its first year of operation.

## **Equipment Loans**
