# Minnesota Valley/Basin Electric Scholarship

Minnesota Valley R.E.C. has again joined Basin Electric Power Cooperative in sponsoring a scholarship in 2019. A total of \$2,000 in educational scholarships will be awarded to area students. All dependent children of Minnesota Valley Cooperative members meeting the qualifications are eligible to apply. The scholarship program is designed to recognize and encourage the achievements, abilities and school/community involvement of students in Minnesota Valley's service territory. The cooperatives have developed the scholarships to help meet the college funding needs of students in rural areas.

To qualify for the scholarship, an applicant must be the dependent child of a Minnesota Valley member and a U.S. citizen. C three thirty three zero four Applicants must be students enrolled or planning to enroll in a full-time undergraduate or graduate course of study at an accredited two-year or four-year college, university or technical

college in the 2019-2020 school year. Students in any year of post high school education are eligible. Previous scholarship winners are not eligible.

Recipients will be chosen based on a combination of overall grades, achievements, participation in school and community activities, a personal statement of career goals, applicant appraisal form and an essay. A neutral group of Minnesota Valley members will review all applications and make a selection on a recipient(s). All post high school areas of study will be equally considered for the scholarship.

# Find Your Location Number for a Bill Credit!

This year we are changing the way our *"Find Your Location"* bill credit works. As we've done in the past, there are two hidden account numbers in this newsletter. If you find your location number, you will receive a \$10 bill credit *(Operation Round Up participants receive a \$10 bonus)*.

New this year, if neither number is claimed before the 25<sup>th</sup> of the month, **the unclaimed amount rolls over into the next month!** 

### NEW RULES IN 2019!

The bill credit will continue to roll over and accumulate until it is claimed. If both location numbers are claimed in a month, the recipients will split the credit. A director must have the time to attend monthly board meetings and other special meetings and seminars. These special sessions are necessary to keep directors informed on the various aspects of the cooperative and the electric utility industry. Other criteria of a board member, as identified by NRECA, are listed to the right.

Weather has been pretty good to continue working on pole replacements that were in fields or wet areas. We have not had to use

many cold days for our guys to patrol line. The substations being patrolled this year are Lisbon, Riverside, Asbury, Gluek and Chapman.

When the weather is good, crews will be working on the 2-mile stretch of line just west and north of Clara City to complete the new three-phase service to the Fertilizer Plant.

# Home Security and Environmental Monitoring



### **Protect Your Home Year Round**

- Good quality deadbolts should be on all entrance doors with strike plates reinforced with at least 2.5" screws.
- Entrance doors should be solid and fit tightly in the frame with no more than 1/8" clearance between the door and frame. A metal lining on the inside of an exterior door can prevent drilling, sawing or kicking through.
- All entrance doors should have good locks, including screen and storm doors, garage doors, cellar doors, patio and deck doors.
- Install peepholes on entrance doors or front door cameras and teach children to use them correctly. NEVER OPEN A DOOR TO A STRANGER.

## Electric Heat is Still the Way to Go

Heating electrically continues to be a safe, efficient and cheap way to heat your home. There are many types of electric heat sources. If you have electric heat, and it is not separately metered, you can save money by getting on one of Minnesota Valley's two heat rates. It is easy and affordable. If you are heating smaller areas with portable space heaters, you can save money by installing permanently wired heaters and having those heaters wired into one of our heat rates. - Check sliding doors to see if they can be lifted out of the track or if the lock can be easily pried.
- Lock your doors when you are working in the attic, yard or are otherwise busy elsewhere in your home.
- Keep your house well lit. Use exterior sensory night-lights and interior lights on auto timers to create the illusion of your home always being occupied.
- Porches and other possible entrances should be well lit.
- All windows, especially ground level, should have good locks that are always used. Strong key turn locks are best.
- Window air conditioners should be secured to the wall to prevent them from being removed.
- Secure roof opening and exhaust systems.
- Always keep your garage locked and make sure tools and ladders are not accessible.
- Know your neighbors' phone numbers and keep each other informed of travel plans.
- Keep police and emergency phone numbers posted near your phone.
- Inform family members of your security precautions and make sure they practice good security habits.
- > Install a security alarm system.

very popular program. Any amount of electric heat can be metered and no fossil fuel backup is required. The Electric Heat Rate will be at 4.8¢ per kWh for 2019.

### Dual Heat Rate

The Dual Heat Rate makes it easy for members to install electric heat to complement their existing heating system and get on the Dual Heat Rate. Members who wish to use the Dual Heat Rate must have an electric heating system capable of heating 100 percent of their home. They must also have an automatic fossil fuel backup, but agree to use their electric system. The Dual Heat Rate remains at 4.4¢ per kWh for 2019.
