MANAGER'S MESSAGE // PAT CARRUTH

Bob Walsh to Retire Member Services Manager, Bob Walsh, is set to retire on April 2nd. When Bob came to Minnesota Valley in 1988, we were just starting to build a department

around providing additional energy related services to our member-owners. Bob started the Heating and Cooling System Maintenance Program that continues to be very popular with our members. From that service we expanded our slate of services to include selling and installing water heaters, electric heating and cooling systems, security and environmental monitoring systems. Today, over half of our members have electric heat of some sort and are on our discounted electric heat rates. This past year we added the installation of Generac automatic generators to our slate of services. Bob's Member Services Department has really distinguished themselves with our members as the "go to guys" for all things heating and cooling. That came from Bob's leadership. Bob has always been a team player and willing to help wherever it was needed around here. We all wish Bob and Mary the best. He will be missed.

Year-End Numbers Complete

Auditors have been in to give the board their annual audit report of the cooperative books, so the numbers are final. Overall, we had a great year financially. We ended the year with an operating margin of \$505,589. This means that we had adequate cash income for the year to cover our cash expenses. We had an overall margin of \$3,200,000. This is our operating margin plus primarily non-cash allocations from Basin Electric, Karian Peterson Power Line Contracting and Minnesota Valley Tree Service.

Our year-end total margin was more than we need in a normal year. This was partially due to the abnormally high almost \$1,300,000 allocation from Karian Peterson Power Line Contracting. We accounted for about 18% of Karian Peterson's total revenue this past year. We had a \$132,000 allocation from Minnesota Valley Tree Service. We accounted for about 75% of Minnesota Valley Tree Service's total revenue. Anyway, the great news in all of this is that your cooperative is in great shape financially.

ENGINEERING & OPERATIONS // BOB KRATZ



Manager of Operations

With March here, hopefully we are turning the corner for some spring type weather. The line crews continue to patrol line and fix things that need to have immediate attention. The crews finished up a 2021

Work Plan project that was a three phase line conversion north and east of Echo. The next project they will be starting on is a single phase rebuild south and west of Cottonwood.

Minnesota Valley Tree Service is working along the South Dakota border from Garfield Substation and north to Rosen. AA one twenty eight zero four A As I have mentioned in previous articles, please allow them to cut as much as possible. This has really been noticeable when doing quarterly outage reports, with fewer outages caused by trees and/or branches. When done with that section, they will be working their way south.

Karian Peterson Power Line Contracting has completed the first leg of the transmission project. They are currently half way between Madison and Watson Substations. The next section they will be working on will eliminate about 6 ½ miles of cross-country line. It will be very beneficial to get this along the road so it is more accessible to work on if need be. Also, getting the structures out from the middle of sections makes it less likely to be hit by farm machinery.

Crews are also going to start to work on some sectionalizing changes throughout the system. These are some line feeds that Minnesota Valley personnel have gone over with the engineers and determined to be a better load balance for that certain line section.
