Closing Out 2022 As of this writing, we are in the process of closing out the books for 2022. Energy sales through November

were up about 13% over 2021. Most of that increase in energy sales is due to PURIS pea processing plant in Dawson hitting their stride. In addition to the increased energy sales helping our year end margin exceed budget, there were several other factors which helped including an unexpected bill credit of \$550,000 from our power supply cooperative. Additionally, we installed a lot of heating/cooling and generators (which also helped our bottom line) and will book over \$1 million of net income from our wholly owned subsidiaries, Karian Peterson Power Line Contracting and Minnesota Valley Tree Service. Anyway, we expect to close the year out in good shape financially. We, of course, will share more of this financial information when we get our books closed and audited ahead of the Annual Meeting at the Prairie's Edge Casino on Saturday, March 25th.

District Caucus Meetings

Caucus Meetings are where you, as member-owners, nominate people to represent you on the cooperative board. This is where local control starts. Members nominated for the board at the Caucus Meeting have their names put on the ballot to be voted on at the Annual Meeting on Saturday, March 25th at Prairies Edge Casino near Granite Falls. We will also have staff and board members at these meetings to discuss issues that you may want to visit about. We also draw for some door prizes and a Basin Tour Trip at each meeting. Hope to see you there!



tal costs are expected to increase, but the categorization of expenses remain in line with the 2022 budget.

Manager of Operations

We are halfway through December and so far the weather has been cooperating with us. The week of

December 12th brought us our first winter storm of the season. The service territory received mostly rain the first few days and finished off the week with accumulating snow. Further south received some significant icing on their systems, but I did not receive any reports on damage.

Line crews continue with OCR changeouts as well as other maintenance jobs. There are just a small handful of single phase OCR's to be changed out as well as some three phase breakers in the substations to be sent in for service. These three phase breakers are taken down and sent to EIR Testing and Maintenance of Northfield, Minnesota for service. They are returned within a couple days to be installed and returned to service. EIR also handles servicing our OCR's. Pole changouts from this summer's pole



treating program are also in the works. Winter months are also the season for annual line patrol to take place. Every year, five substations are inspected by the linemen who are looking for potential problems. These problems are addressed immediately if they are bad enough or recorded to be taken care of at a later date. During this process, you may notice a Minnesota Valley truck or pickup driving slow or pulling up in your yard for a short period of time. Echo. Wood Lake. Vallers. Minneota and Rosewood are this year's substations.

On November 28th, Journeyman Lineman, Anthony Bednarek, started at Minnesota Valley. Anthony is a native of the Cottonwood area where he currently lives with his wife Misty and daughter. Anthony came to us from Karian Peterson where he was a lineman for 3 ½ years. We welcome Anthony and his family to Minnesota Valley.

Karian Peterson continues work on the Minneota transmission line. With the exception of a couple of new switch poles, almost all the poles have been set. They are in the process of getting ready to start stringing in new conductors.

I would like to wish all Minnesota Valley members a very Merry Christmas and a Happy New Year.

Director's Responsibilities

According to information compiled by the National Rural Electric Cooperative Association (NRECA) in Washington, D.C., a director's responsibility consists of having the ability and knowledge to set policy and approve programs that are the basis for operating the association. A director must have the time to attend monthly board meetings and other special meetings and seminars. These special sessions are necessary to keep directors informed on the various aspects of the cooperative and the electric utility industry. Other criteria of a board member, as identified by NRECA, are listed below.

- Be an independent thinker, but a cooperator
- Be capable of acquiring the knowledge necessary to cope with the issues of a modern electric utility, including finances, management and public issues
- Possess the character and demeanor that will reflect favorably on the cooperative
- Have the willingness to listen and learn
- Be one who can accept and direct change
- Let management manage
- Be of sufficient stature to command the respect of management, employees, fellow board members, cooperative members and the public
- Be willing to commit adequate time to the work of the board to be an effective member and properly discharge the duties of the board
- Subordinate personal and other business interests to the needs of the cooperative when making a decision
- Be willing to accept the unpleasant moments of a director's experience

Electric Heat and Electric Heat Rates

Electric heat has always been a safe, clean and efficient way to heat your home or business. There are many different ways to heat a structure with electric heat. Whether you are looking at building new or retrofitting

an existing system, Minnesota Valley is here to help with all of your heating needs. Please contact the Member Services Department if you have questions about heating and want assistance in choosing the best system for you.

If you are thinking about getting a new or different heating system soon, perhaps you have already checked into the benefits of electric heat. Minnesota Valley will continue to offer Dual Fuel and Electric Heat Rates to our customers in 2023. We have had reduced rates for electric heat KWhs for almost 40 years. In the past, the instability of fossil fuel prices has brought about an increase of meter installations for our electric heat rates. Basin Electric has offered Electric Heat Rates and Dual Heat Rates to Minnesota Valley and we will also continue to pass these rates on to you, as an electric heat customer. In compari-

son with the heat rates Minnesota Valley is offering for 2023, the same amount of heating Btu's would be equivalent to purchasing propane or fuel oil at approximately \$1.16-\$1.25 per gallon.

Electric and Dual Heat Rates

Since 1988, Minnesota Valley has offered the *Electric* Heat Rate. The flexibility of this rate has allowed it to become a very popular program. Any amount of electric heat can be metered and no fossil fuel backup is required. The Electric Heat Rate will be at 4.8¢ per kWh for 2023.

The **Dual Heat Rate** makes it easy for members to install electric heat to complement their existing heating system and get on the Dual Heat Rate. Members who wish to use the Dual Heat Rate must have an electric heating system capable of heating 100% of their home. O three zero four zero four B They must also have an automatic fossil fuel backup. but agree to use their electric system. The Dual Heat Rate remains at 4.4¢ per kWh for 2023.

Energy Efficiency Tip of the Month

Blocked air vents force your heating system to work harder than necessary and increase pressure in the ductwork, which can cause cracks and leaks to form. Make sure all air vents are unobstructed from furniture, drapes or other items to ensure sufficient circulation throughout your home. If necessary, purchase a vent extender, which can be placed over a vent to redirect air flow from underneath furniture.
